FY 18/19 Budget Ordinance Adoption:

City Clerk Vicki Wainwright asked for the Council to adopt the Fiscal Year 18/19 Budget Ordinance. The estimated proposed revenues and expenditures for the General Fund are as follows:

Comprehensive Plan: Gerald Mixon RVRC:

Mr. Mixon had to cancel at the last minute.

Department Head Reports:

Public Works Director David Windham stated that there had been several complaints of pot holes and wash-outs around the City and at this time those have been repaired. He also said that there are some streets that have been cut for water main repairs and those still have to be repaired, but plans are in the works to do that as soon as possible.

He also informed the Council that yesterday (September 12th) one of the deep wells went out. At this time it has been pulled and he should know something about it by the end of the week.

The City has been monitoring Hurricane Florence as it approaches the Carolina coast. Forecast models predict that once it makes landfall it may take a southward bend and if so the City of Butler could be on the edge of the storm. At this time it looks like it will mostly be some wind and rain, but the City is ready if the need arises.

Council Meeting September 13, 2018

He announced that the Christmas Program for the City of Butler has been scheduled for Thursday, November 29th at 6:30 PM on the Courthouse square. (weather permitting)

He said that the Pre-Construction meeting for the 19/96 meeting was held this week and it getting underway. The project is a 150 day project, but he expects completion to be within a month and a half. (weather permitting) Mayor Whitley stated he was glad to see it, as this project has been a long time coming.

Mr. Windham said that he has received several calls regarding the flagging being done around Butler. He said that that flagging is surveyors for the USDA project that the City is working on.

Mr. Windham asked Mayor and Council for approval to do some Christmas light upgrades. He would like to use \$10,000 from street SPLOST funds. Mayor Whitley stated that would be an excellent idea. A motion for approval was made by Councilman Chas Gassett and a second was made by Councilman Glenn Harris. The vote was unanimous. Mayor Pro-Tem Guinn and Councilman Jenkins were absent)

Chief Kain Cobb said that during the month of August the Police Department worked four traffic accidents, three of those with injuries. They made 113 traffic stops and issued 65 citations. They conducted four burglary/theft/financial crimes and one drug related offense. They made four arrests. They also responded to twenty nine domestic calls. In total they responded to 272 incidents in August.

They Butler Police Department is currently working on getting a GCIC terminal for the department so that they can enter their own bench warrants.

Fire Coordinator Eddie Moulton stated that the Butler Fire Department responded to 13 calls in August. He also said that the students in the Fire Fighter 1 class should be done by the end of the month.

With no other business to discuss, Mayor Whitley called for a motion to adjourn. A motion to adjourn was made by Councilman Chas Gassett and a second was made by Councilman Glenn Harris. The motion was unanimous and the meeting was adjourned.
