DEPARTMENT HEAD REPORTS:

Public Works Director David Windham informed the Mayor and Council that the 2019 CDBG project is 60/65% complete and should be completed by the middle of March, weather permitting.

Police Chief Kain Cobb said that the Police Department worked 41 traffic stops in January with 15 citations issued. He said that they also had 14 domestic calls. He informed the Council that for the first time the City of Butler Municipal Court will be held virtual via ZOOM on February 10th.

Fire Coordinator Eddie Moulton said that the Butler Fire Department ran 4 calls in January. Those were 1 structure fire, 1 vehicle accident, 1 vehicle fire, and 1 smoke in building call. He said that the fire department has been working on servicing all the vehicles. He announced that the Fire Department has received a 50/50 grant in the amount of \$4500.00.

ADJOURN: With no other business to discuss, a motion to adjourn was made by Council Person Amanzie Jenkins and a second was made by Councilperson Jacob Hopkins. The vote was unanimous, and the meeting was adjourned.
