DEPARTMENT HEAD REPORTS

Public Works Director David Windham said that the 2019 CDBG is moving along and will hopefully be finishing up in approximately 2 ½ weeks. Weather permitting, he hopes to start patching the holes created by the project work, in about two weeks or so in the Clover Lane, Plantation, Timber and Pineview areas.
