**DEPARTMENT HEAD REPORTS:**

**Public Works Director David Windham** said that it was good to be back having face to face meetings again after several months of zoom meetings due to the COVID 19 virus. He said that he is currently working with the engineers and contractors on the 2019 CDBG, which will be around the areas of Pineview, parts of Clover Lane, Plantation and Timber Lane. The Pre-Construction meeting should be held in the next week or two and at that time a start date and a tentative finish date for the project will be set. Other than that his staff is just dealing with the heat and the rain.

Councilman Glenn Harris asked where the City stands on the 2017 CDBG and was informed that it is closed out except for some erosion issues. Councilman Harris also asked about the hay at the LAS plant. He was told that it was being mowed and sprayed and it will be baled one more

time, at which time samples would be pulled to test for metals in the hay. Once that occurs he will know more about which direction to take with the LAS fields. He stated that the LAS fields are not under a hay contract at this time.

**Chief of Police Kain Cobb** said that for the month of June the police department responded to two fights, one burglary, thirteen domestics, one drug case, two thefts, two prisoner transports, made forty-six traffic stops with two arrests, for a total of one hundred and fifty two incidents. He said that he would need them to enter into an executive session to discuss personnel.

Mayor Pro-Tem Ed Guinn stated that he attended the Chief's Diploma Program graduation in Ogelthorpe on Saturday, July 11<sup>th</sup> with Chief Cobb. This program involves 27 counties. He said that thirty-six students graduated with a high school "home-school" diploma. He stated that he was very impressed with the program. Chief Cobb said that the next class is expected to have about seventy-five students.

**Fire Coordinator Eddie Moulton** said that the Fire Department ran five calls last month. Those were one woods fire, two landing zones, one vehicle accident, and one vehicle fire.

**EXECUTIVE SESSION:** Mayor Whitley said that with nothing further to discuss, he and the Council needs to enter into an Executive Session to discuss personnel. A motion to enter into an Executive Session was made by Mayor Pro-Tem Ed Guinn and a second was made by Council Member Amanzie Jenkins. The vote was unanimous. *(Council Member Deborah Williams was absent)*

**(Regular Session continued)**

After discussion in Executive Session the Mayor and Council came back into the regular meeting. Nicole Murillo had appealed her termination and asked to be allowed to resign instead of termination so that it would not have a negative effect on her POST records. A
