Resolution for "Pouring License" for Beer and/or Wine

City Clerk Vicki Wainwright read the new resolution allowing for retail businesses to apply and purchase a "Pouring License" allowing to serve beer and/or wine for consumption on premises. Ms. Wainwright then requested a motion to adopt the resolution. A motion to adopt the Resolution was made by Councilperson Deborah Williams and a second was made by Councilperson Jacob Hopkins. The vote was unanimous.

Fees for Beer and/ Wine Pouring License:

City Clerk Vicki Wainwright stated that she has reached out to City Clerks across the State inquiring as to what other Cities charge for a pouring license for beer and/or wine. She said that the majority charge \$500.00 to \$750.00 per year per beer or wine. She recommends to the Mayor and Council to charge \$500.00 for pouring of beer license and \$500.00 for pouring of wine license. \$1000.00 if both licenses are purchased. She added that the fees could be changed from time to time by Mayor and Council if needed.

A motion to charge \$500.00 for a wine pouring license and \$500.00 for a beer pouring license was made by Mayor Pro-Tem Ed Guinn and a second was made by Councilperson Glenn Harris. The vote was unanimous.

their cut-off is so that the citizen can cut off their water should they have busted pipes in their house. City of Butler employees can not always get there quickly in order to turn off the water.

He reminded the Mayor and Council that City Hall will be closed the Martin Luther King Jr. holiday on Monday, January 16th.

He said that he is working with the Grant Writer on the 2021 CDBG as some of the bids came in over budget due to inflation. Councilperson Williams asked what will happen with the project if the extra funds are not available and was told that the project would have to be scaled back. Mr. Windham also said that the City is doing a complete electrical rehab on all wells using ARPA funds.

The Taylor County Chamber of Commerce and the Taylor County Development Authority received a grant from Flint Energies that allows for directional signage to be placed around the County in Butler and Reynolds. Mr. Windham thanked them for the signs to help improve Butler and the surrounding area.

Police Officer Shelby Cloniger attended the meeting in place of Chief Matthew Woodard, who is ill. He introduced two new hires, Landon Aldridge and Kelsie Bloodworth, that recently graduated from thirteen weeks of mandated training in Forsyth. The Council welcomed them.

Officer Cloniger said that the Butler Police Department responded to 308 incidents last month with 95 citations being issued along with 37 warnings.

Officer Dakota Windham's last date to work was January 1, 2023. He will be continuing his law enforcement career in Dooley County.

Fire Coordinator Eddie Moulton stated that the Butler Fire Department responded to 11 calls in December 2022. He also said that in 2022 the Butler Fire Department responded to 211 calls.
