DEPARTMENT HEAD REPORTS

anything to do with the project and was told that the City will be putting a fire hydrant on that location. When asked why the contractors were digging such a deep whole, Mr. Windham stated that they are building a retention pond to keep the water from flowing onto the street behind the Piggly Wiggly. This was done at the recommendation of the City's engineer. Councilman Harris asked about the issue where some customers had complained to Sanford Bishops office regarding the water bill rates, and was told that the City has not heard anything else from it. The Clerk had reached out to Bishops office and explained the rates. Rates are determined to be a certain value in order to receive grant and loan funds from the Federal Government.

Chief of Police Matthew Woodard stated that he had provided everyone a monthly print -out on the stats of the department.

Mayor Pro-Tem Ed Guinn asked Chief Woodard how the collections on fines are, and if there are a significant amount outstanding. Chief Woodard stated that he would not say there is a lot outstanding, and usually what the department does is that if the citation holder does not show up for court they will receive a bench-warrant, and once that warrant is in the system if they end up stopped any place and find out they have a bench-warrant, they will typically end up paying the fines. Mayor-Pro Tem Guinn asked Chief Woodard to present a report in December (next month) so that the Mayor and Council will know. Guinn stated that he knows in the past the outstanding fines was out of hand.

Fire Coordinator Eddie Moulton said that the fire department ran fourteen (14) calls last month. Those were one (1) smoke in the area call, three (3) grass fires, six (6) vehicle accidents, one (1) vehicle fire, one (1) electrical fire, one (1) rescue where a deer hunter had fell from his stand, and one (1) gas leak.

Mr. Moulton asked for approval to surplus a 2005 Chevrolet Colorado. A motion was made by Mayor Pro Tem Ed Guinn and second was made by Councilperson Glenn Harris. The motion was unanimous. (*Councilperson Williams was Absent*.) Mr. Moulton also said that he would like a motion to trash an old metal detector that the City has not been able to surplus on Gov Deals. Councilperson Jacob Hopkins made the motion to trash the metal detector and a second was made by Councilperson Glenn Harris. The vote was unanimous (*Councilperson Williams was absent*)
