#### **INCODE ERP PRO 9 (Cloud based upgrade) approval:**

City Clerk Vicki Wainwright stated that she would like approval to upgrade the current INCODE software to a cloud-based platform. This upgrade will also include a human resource module and a content management module. She said that this will increase the annual cost, but feels that the upgrades will be worth it. A motion to approve the upgrade was made by Mayor Pro-Tem Ed Guinn and seconded by Councilperson Jacob Hopkins. The vote was unanimous.

## **DEPARTMENT HEAD REPORTS**

**Public Works Director David Windham** said that the downtown sidewalk project is scheduled to begin on April 1<sup>st</sup>. He said that two town hall meetings were held to inform the business owners of the project and to answer any questions or concerns they may have but no business owners attended either meeting. The notices of the meetings were in the Taylor County News and on Facebook and the City's website.

Questions were asked regarding the crosswalks in the plans and Mr. Windham stated that the crosswalks would not be brick or stamped concrete, but more than likely just painted. He said they would not be raised. He said that DOT would not allow bricks.

Councilperson Williams asked about some property in the Venus St/Thomaston Highway area that is having drainage issues. Mr. Windham said that grass had been planted there numerous times but it would not grow. The property is a low lying area and water naturally goes to the lowest point. He said he would try to plant grass again to try to resolve some of the issues on that property.

**Chief Matthew Woodard** stated that his report is in the binder. He also said that there is a local person in a mental health crisis that seems to be getting worse, and the Sheriff has stated that the jail would not take him. He plans to meet with Representative Stinson to discuss alternatives.

**Fire Coordinator Brandon Maddox** said that the Butler Fire Department ran 23 calls in February. Those were two traffic accidents with entrapment, five accidents with injuries, eight wildland fires, one trouble unknown, one fire alarm, one medical alarm, one lift assist, one service call, two unconscious person calls, and one wires down call.
